A common EASD-ESC scholarship will make it possible to invite six outstanding investigators to attend and present their work at both the ESC and the EASD meetings.

This is just a short preview of some of the new and innovative aspects of your Congress. As the preparation of the programme evolves, further details will be disclosed in the ESC Newsletters that can be found on the ESC Web Site (<http://www.escardio.org/>). We trust that you will share our excitement about what promises to be another great scientific and educational event. Make sure to plan well ahead and join colleagues and professionals from around the world in Munich to share and celebrate our common passion.

SCIENTIFIC PROGRAMME

PRE-ARRANGED PROGRAMME

All sessions are organised by the Congress Programme Committee, the Associations and Working Groups of the European Society of Cardiology and the ESC Councils.

Symposia (SY) allow for in-depth discussion of recent developments in the various fields of basic science, epidemiology and clinical cardiology.

Clinical Seminars (CS) are designed to highlight what every clinician, who is not an expert in that field, should know about subspecialty topics.

Debates (DE) provide a lively yet balanced discussion on controversial issues.

How-to sessions (HT) are providing a unique opportunity for intense interaction between a limited audience and experts in the field.

Basic Science Track is a series of sessions focusing on translational research, which will be particularly attractive for basic scientists, but also for clinicians with an interest in basic science.

Bench to Bedside
Sessions presenting new science that has emerging clinical implications are identified by this specific tag. These sessions should attract basic scientists as well as clinicians.



FOCUS Cardiology Practice

The FOCUS Cardiology Practice sessions address patient-oriented clinical decision-making. Experienced clinicians present cases and discuss diagnostic and therapeutic options in an interactive manner with the audience. The application of guidelines and optimal patient management are critically reviewed.



FOCUS Imaging Intervention

The FOCUS Imaging Intervention sessions address current problems and new developments in catheter-based and surgical interventions, as well as non-invasive diagnostic procedures. Experts will demonstrate these techniques LIVE, integrating unlimited audiovisual facilities and audience interaction.



ABSTRACTS BASED PROGRAMME

More than 2.500 abstracts will be presented during the 5 days of the Congress.

Oral Abstract Presentations

These reports will be of particular interest to other investigators in related fields, but also to clinical cardiologists.

NEW EASD scholarship on "Diabetes & the Heart"

Six outstanding investigators will be invited to attend and present their work at both meetings of the ESC and the EASD.

Featured Research Sessions

Five of the leading abstracts relating to particular topics are presented. The concluding editorial presentation will be given by a well-known researcher, who will put the abstracts in the perspective of current developments in the field.

In order to respond to the growing burden of cardiovascular disease in diabetics, the emphasis of this edition of the Congress will be placed on the cardiac disorders associated with diabetes. Latest results and innovations will be presented during a series of sessions identified as the "Diabetes Track". This initiative is a joint venture between the ESC and the European Association for the Study of Diabetes (EASD).

Named Lectures

Renowned specialists will hold four prestigious European Society of Cardiology lectures: on clinical cardiology (the Grüntzig and Denolin lectures), on population sciences and on basic science.

Hot Line / Clinical Trial Update Sessions

The Hot Line and Clinical Trial Update sessions will once again present the most important new clinical trial results relevant for clinical practice.

Highlight Session

This main session provides an overview of all new and exciting developments in basic and clinical sciences as presented at the congress. The whole congress summarised for you in just 90 minutes!

Nursing Programme

The ESC acknowledges the contribution of nurses and laboratory technicians to patient care. Accordingly, a special programme will be presented focusing on nursing care and research in cardiovascular diseases.

Industry Satellites and Workshops

Cooperation between clinicians, researchers and the pharmaceutical and technical industries has significantly contributed to a better understanding and management of patients with cardiovascular diseases. This is reflected in a series of symposia organised by industry as part of the congress programme. In addition workshops sessions will address current practice and usage of new medical devices & equipment.

NEW – EBAC Accredited Educational Programme

Recognition of the high quality of the programme is witnessed by endorsement from the European Board for Accreditation in Cardiology (EBAC), which can now be extended under strict conditions to some of the sessions that are made possible through unrestricted educational grants, an initiative that is indicative of the commitment of our industrial partners to third cycle and post-doctoral training.

ABSTRACT SUBMISSION SERVICE

An important feature of the ESC On-line Services is the Abstract Submission Service, which is user-friendly and the unique way to submit abstracts for the ESC Congress 2004.

IMPORTANT!

Your abstracts **MUST** be submitted no later than **14 FEBRUARY 2004 (Valentine's Day)** on the ESC Web Site: www.escardio.org

After this date the Abstract Submission Service will no longer be available. The ESC On-line Services are available for abstract submission from December 2003. Only abstracts submitted via the ESC Web Site will be considered for selection. Abstracts sent by mail, fax or E-mail will not be accepted.

Some important points to keep in mind when preparing your abstract submission:

➔ You can enter **as many abstracts as you want** and you may exit the Abstract Submission Service at any time, leaving your abstract as a draft (early version) on the ESC Web Site.

➔ Your abstract data is **protected** by your confidential subscriber user ID and password. Use your already existing user ID and password (or use the Free Subscription button, if you are new to the service)

➔ If your abstract contains graphics, images or tables, use the appropriate editing features. Abstracts with tables and/or images in the abstract body text will not be accepted.

➔ The **size** of the abstract is calculated in percentage. The size, including images and tables cannot exceed 100%. This corresponds to approximately 400 words without graphics or images.

➔ A **Help** feature providing you with detailed information is available at each submission step. If you still have questions after consulting the Help and Frequently Asked Questions features, or if you encounter technical problems, please send an E-mail to abstracts@escardio.org Support will be available Monday – Friday from 9:00 to 17:00.

➔ Each abstract will be assigned a specific abstract number, which is your **reference number** for any queries to the ESC concerning your abstract. Please make sure to print out you list of abstract numbers, before the service closes on the 14 February 2004.

NEW - NEW - NEW - NEW

Every abstract needs to be identified as either **"BENCH"** or **"BEDSIDE"**

BENCH: animal studies or in vitro experiments at the molecular, cellular or tissue level (including human tissue). The core data are generated in the lab.

BEDSIDE: patient studies. The core data are generated during clinical studies or interventions.

The **results** of the abstract selection will be available on-line in May 2004.

Remember to send your abstracts well in advance to avoid last minute rush!

The elegant Maximilian Street takes us back to the centre of town offering a view of the Bavarian Parliament, Deutsches Museum, Royal Palace and the Opera House.

In the ancient part of town we point out the well-known Hofbräuhaus, the medieval town gates and the colourful open air market (Viktualienmarkt).

2) Walking Tour Through the Old City of Munich (1,5 hours)

Hundreds of masterpieces are exhibited and this is one of the best museums in Germany.

4) Visit of Munich and the Nymphenburg Palace (3 hours)

This Tour will show the guests the main highlights of Munich and includes a visit to the Nymphenburg Palace. To celebrate the birth of their son and heir, Elector Ferdinand Maria and his consort Henriette Adelaide of Savoy appointed the architect Agostino Barelli in 1664 to build them a summer residence west of Munich. A famous feature of the palace is the "Gallery of Beauties", painted for King Ludwig I by Joseph Stieler but also the massive Great Hall ("Steinerner Saal"), decorated in the Rococo style under Elector Max III is a master piece of decorative arts.



5) Visit of Munich and the "Pinakothek der Moderne"

This Tour includes a visit of the brand new contemporary art museum "Pinakothek der Moderne". For the first time, a museum gathers architecture, design, painting and sculpture under one roof. The "Pinakothek der Moderne" is one of the largest museums for art of the 20th and 21st century in the world.

II – Full-Day Tours

1) Visit of Neuschwanstein and Linderhof Palaces

(9 hours)

Hidden in the seclusion of the mountains Ludwig II. built two of his dream castles: Neuschwanstein and Linderhof. This excursion shows you two extraordinary castles, both testifying the vision of Bavaria's fairytale King.



- **Neuschwanstein** illustrates the ideals and longings of Ludwig II more vividly than any of his other buildings. The castle was not designed for royal representation, but as a place of retreat. The frescos of Neuschwanstein were inspired by the operas of Richard Wagner, to whom the king dedicated the castle.



- In 1868 Ludwig II had already made his initial plans for **Linderhof**. The new building developed around the forester's house belonging to his

father Maximilian II, which was located in the open space in front of the present palace. Linderhof Palace, the result of a long building and rebuilding period, is the only large palace King Ludwig II saw completed.

2) The Romantic Road

From the Main Valley to the foot of the Bavarian Alps, by way of peaceful valleys and an idyllic, rolling countryside the "Romantic Road" itinerary recalls at every stage of its course some aspect of the past. Along the Romantic Road you will first reach Harburg, one of the oldest, biggest and best preserved castles of Southern Germany. Through the Swabian crater landscape passing Dinkelsbühl you will arrive in Rothenburg, the most perfectly preserved medieval town in Europe: once behind the ramparts in the car-free central enclave, the visitor is faced with Rothenburg's ancient houses, fountains and narrow cobbled lanes, seems as if he is in some kind of time-warp, plunged back into the middle of the 16th century!



3) Chiemsee and Herrenchiemsee

(8 hours)

The last of the three castles of Ludwig II is certainly the most flamboyant. Herrenchiemsee is an incredible replica of Versailles, on an island in the middle of the Chiemsee, Bavaria's largest lake. When Linderhof turned into a Royal Villa rather than the 'New Versailles', Ludwig II looked elsewhere for a suitable site for this cherished dream. One of the most remarkable aspects of Herrenchiemsee is the fact that it



reached its current appearance shortly after Ludwig's death in 1885, seven years after the stone foundation was laid. After visiting the castle, you will continue by boat to the neighbouring island Fraueninsel where you will visit the Benedictine church built in the 13th century and rebuilt in the gothic style in the 15th century. After a walk in the charming fishing village, you will travel back to Munich.
